Penobscot Nation Department of Natural Resources Non-Member Hunting Access Permit Application

General Information:

- A State of Maine Hunting License is required unless you are accompanied by a Penobscot Nation Guide, are a tribal member spouse, or a member of a federally recognized tribe.
- All permit applications require a tribal member affiliate's signature.
- ➤ A non-refundable application fee is required. This fee is waived for non-member spouses. You must enclose a self-addressed stamped envelope to receive a permit.
- ➤ Applications must be received or post marked no later than August 31. (Applications after that date will be filled on a first come first serve basis.)
- Incomplete applications will not be processed.
- Make checks payable to the Penobscot Nation.
- Tribal members must be at least 18 years of age to accompany non-members.
- ➤ Non-member access permits require a tribal member be within 1 mile of the territory requested.
- Please be sure to reference the most recent Chapter VII Inland Fish and Game Regulations for requirements regarding non-member hunting seasons, bag limits, and tribal member accompaniment.
- ➤ By signing the application form both parties acknowledge all rules, regulations, and requirements set forth by the Penobscot Nation and DNR; and that non-members hold no responsibility to the Penobscot Nation or their tribal member affiliates for damages or personal injury while utilizing said permit.
