(f) Order the defendant to remove, destroy or return any private images or direct the removal, destruction or return of same, order the defendant to cease disseminating the private images and further order the defendant from any future dissemination of the private images.

(g) Order the defendant to pay monetary compensation for losses that I have incurred as the result of the harassment.

(h) Order the defendant to pay for my attorney's fees and court costs and to order any other necessary and proper relief.

(i) Order the defendant to refrain from destroying, transferring or tampering with my passport or other immigration document in the defendant's possession.
